# **Notification**

Dear Candidates,

Please read the following additional important instructions carefully before attending the examination.

### **Important Instructions and Guidelines**

It is an Online Examination system, fully computerized, user friendly, having advanced security features making it fair, transparent and standardized.

Candidates are requested to follow all the instructions.

- 1. The examination does not require using any paper, pencil and calculator.
- 2. The students will have to enter their Roll Number as Username and Password (which has been sent to their registered email-id).
- 3. The student proceeds answering the questions one by one by clicking on the check box/circle next to the chosen answer.
- 4. The candidate can move to First, Last, Previous, Next and answered/unanswered questions by clicking on the buttons with respective labels displayed on screen throughout the test.
- 5. The answers can be changed at any time during the test and are saved automatically.
- 6. The remaining time is shown on the screen.
- 7. The system automatically shuts down when the time limit is over.
- 8. No candidate should adopt any unfair means or indulge in any unfair examination practices. If any candidate is found using unfair means or indulged in disorderly conduct at or in connection with examination, actions deemed appropriate including debarring from the examination shall be taken.

#### Unfair means shall include the following:

- 1. Keeping in possession or access to any of the following during examination:
  - Any paper, book, note or any other unauthorised material which has relevance to the syllabus of the examination paper concerned.
  - Mobile Phones or any electronic gadget even in switch off mode, which can potentially be used for communication or copying for communication or copying.
  - Anything written or signs made on the body of the candidate or his/her clothes/garments, hanky etc., which may have relevance to the syllabus of the examination.
  - Anything written on any other instrument or any kind of furniture or any other substance which may have relevance to the syllabus of the examination.
- 2. Talking to any another person or any unauthorised person inside or outside the examination room during the examination hours without the permission of the invigilator. During the examination, only the candidate must be present in the room (with the exception of Scribe).
- 3. Impersonating any candidate or getting impersonated by any person for taking the examination.
- 4. If the candidate is found giving or receiving assistance in answering the questions to or from any other candidate/person in the examination hall or outside during the examination hours.
- 5. If the behaviour of the candidate on being caught is unsatisfactory or the candidate disobey, uses proctorial instructions/resistance/violence against the proctor/invigilator or any person on examination duty or consistently refuses to obey the instructions.
- 6. Swallowing or attempting to swallow or destroying or attempting to destroy a note or paper or any other material.
