## Terms and Conditions

### 1.Name of the Position and No. of Posts:

Project Scientist II - 01

**2.Educational Qualification:** Master's Degree in Engineering OR Technology from a recognized University or equivalent with minimum 3 years experience in Research and Development in Industrial and Academic Institutions or science and technology organizations and scientific activities and services.

### 3. Job Description:

The candidate is required to provide services in the areas as placed below:

- a) Design and develop safety systems for clean room.
- b) Operation and maintenance of Air Handling Unit.
- c) Day-to-day operation of clean room.
- d) Troubleshooting problems associated with clean room.
- e) Procurement of clean room consumables.
- f) Communicate with clean room vendors for different problems of clean room.
- g) Operate instruments like optical profiler and mask less lithography.

### 4. The scope of work:

Complete maintenance of the clean room and any other duties assigned from time to time by the Competent Authority.

### 5. Period of Engagement:

The assignment will be purely on contract basis. The initial engagement would be for a period of one year, which may be extended depending upon the requirement and performance review.

The assignment would be on a full-time basis, and they would not be permitted to take up any other assignment during the period of contract.

### 6. Age Limit:

Below 50 years of age on the last date of receipt of application.

### 7. Remuneration:

A fixed monthly amount of Rs.70,350/-p.m plus 27% HRA.

### **8. Selection Procedure:**

Candidates meeting the conditions shall be offered the position on the basis of experience, qualification, etc. A Committee will be set up for the purpose.

### **9. Working facilities to be provided:**

Only the basic facilities/infrastructure will be provided to the candidate. No Transport or Telephone/Internet facility at residence, stenographic/clerical support, etc., shall be provided.

### **10. Other entitlements**

- a) **Leave:** Paid leave of absence will be allowed at the rate of 2.5 days for each completed month. Accumulation of leave beyond a calendar year shall not be allowed.
- b) **Accommodation/HRA:** If accommodation provided, HRA will not be applicable.
- c) **Transport Allowance:** No TA will be paid.

### **11. Working hours:**

The candidates shall have to work as per the working hours of the Centre and required to mark the attendance online.
