TERMS & CONDITIONS:

- 1. Any item not specifically mentioned in the technical specification but essential for successful implementation of the system (in the opinion of the bidder) must be brought to our notice and quoted accordingly.
- The successful bidder immediately after the award of the AMC Order shall prepare a detailed plan of service visit.
- The Bid validity should be 30 days.
- Performance Security: The successful bidder has to provide 3% Performance Security in the form of Bank Guarantee within 15 days after receiving Purchase Order.
- Payment terms: Monthly on receipt of service report along with invoice.
- Late & delayed quotations will not be considered.
- As time is the essence of the contract, service visit mentioned in the AMC Order should be strictly adhered to. Otherwise the successful bidder will forfeit Security Deposit if the supplier fails to take service visit, the supplier is liable to pay liquidated damage of 0.5% of AMC Order value per every week of delay subject to a maximum of ten percent beyond the due date. Such money will be deducted from any amount due or which may become due to the supplier. JNCASR reserves the right to cancel the AMC Order in case the delay is more than ten weeks. Penalties, if any, will be deducted from the Security Deposit. The maximum amount of penalty shall be ten percent. Liquidated damages shall be levied on the AMC Order value, freight, insurance and duties.
- The place of Applicable Law / Jurisdiction is Bengaluru, Karnataka, India.
- Decision of the President, JNCASR will be final.
- 10. Goods & Service Tax: Please note that JNCASR is eligible for GST Concession under 45/2017 notification and IGST under 47/2017 notification. A certificate to this effect will be issued. The prices can be quoted either in foreign denominations or in INR. Exchange rates as on the date of price bid opening will be taken into account for comparison purpose.
