## NOTICE INVITING TENDER

Jawaharlal Nehru Centre for Advanced Scientific Research, Jakkur invites sealed tenders in Two Bid System (Technical & Commercial) from qualified and experienced Vendors for Supply of 82 Nos. of Cots for Hostel Block as per the terms and conditions below and as broad specifications shown in ANNEXURE and attached image.

## TERMS & CONDITIONS:

- Delivery period should be Eight weeks from the date of Purchase Order.
- Any item not specifically mentioned in the technical specification but essential for successful implementation of gas line system and associated accessories (in the opinion of the Bidder) must be brought to our notice and
- At the time of installation, if it is found that some additional items are required to meet the operational requirement of the configuration, but not included in the Bidder's original list of deliverables, the Bidder shall supply such items to ensure completeness of the configuration at no extra cost.
- The Bid validity should be 60 days.
- The successful Bidder immediately after the award of the Purchase Order shall prepare a detailed plan of supply, installation of gas line system.
- Performance Security: The successful bidder has to provide 3% Performance Security in the form of Bank Guarantee within 15 days after receiving Purchase Order.
- Payment terms: 100% payment within 30 days from the date of supply, installation, testing and commissioning of the project and PBG for 10% of PO value valid for 60 days beyond the date of commissioning.
- Late & delayed quotations will not be considered.
- As time is the essence of the Contract, delivery period mentioned in the Purchase Order should be strictly adhered to. Otherwise the successful Bidder will forfeit Security Deposit. If the supplier fails to supply, install and commission the system as per specifications mentioned in the Purchase Order within the due date, the supplier is liable to pay liquidated damage of 0.5% of Purchase Order value per every week of delay subject to a maximum of 10% beyond the due date. Such money will be deducted from any amount due or which may become due to the supplier. JNCASR reserves the right to cancel the Purchase Order in case the delay is more than Ten weeks. Penalties, if any, will be deducted from the Security Deposit. The maximum amount of penalty shall be 10%. Liquidated Damages shall be levied on the Purchase Order value, freight, insurance and duties.

- 13. Goods & Service Tax: Please note that JNCASR is eligible for GST Concession under 45/2017 notification and IGST under 47/2017 notification, will issue a certificate to this effect.

The Bidder name, the nature of the envelope (either Technical Bid or Commercial Bid) must be clearly mentioned on top of each of the envelope. The sealed proposals must be addressed to Senior Stores & Purchase Officer, JNCASR. The proposals should be submitted at the Stores & Purchase Department, JNCASR.

## Quanty Required: 82 Nos

#### COT FRAME : -

Cot Main Frame made out of 80x40x16g CRCA Tube for four sides, with CO2 Welding as per drawing.

80X40X16G tube 4 ends shall be made curvature to suit 50mm dia tube for better gripe & Strength and also for hetter aesthetic.

Cot shall be knockdown. No clamp should be visible outside or inside the frame. After assembly COT should be very strong & No lateral shake will accept.

Powder coating shall be good finishing & thickness shall be 80 to 90 microns.

#### COT LEG : -

Cot Leg made out of 50mm dia 16g CRCA tube in Combination of 50x25x16g CRCA tube with CO2 Welding.

Head rest side shall be 4 Nos of cross support 50x25x16g tube welded in Co2 and all the welding joint shall be smooth finishing.

Foot rest side shall be 3 nos of Cross support 50x25x16g tube with CO2 welding and 3 Nos of 50x25x16g cross support shall be provided as per drawing. The entire welding joint shall be smooth finishing.

Cot leg shoes shall be Nylon & the thickness shall be minimum 6+ or -0.02mm

Cot leg top shall provide half radios cap matching to 2" dia tube with 12.5mm dia MS Tube hole to match for Mosquito net frame fixing.

### COT MOSQUITO FRAME : -


Mosquito frame shall made out of 12.5mm CRCA MS Tube shall be knockdown, No welding. It can be not bolt system for assembly & disassembly and also all the corners shall be rounded, no sharp edges acceptable


19mm BWR Plywood shall be provided with both side polish & necessary clamping to be provide for better fitting & strength. Make. Century / green ply ,

All the hardware shall be high tensile with good quality. Blackening finish. It should not get rested were ever using bolt along with one number 2mm thick plain washer & flat Spring Washer.

L1 person has to be produce one number of Sample for approval. Once get the approval in writing then only bulk production should be taken up. Powder coating color approval will be given in writing. Marranty period - 10 years.
