- 2. The bidder should have executed similar work in large research institutions like IIT'S, IISc, NCBS, ISRO, CeNS, TIFR, JNCASR and other establishments. The contractor should have executed a single project of value not less than Rs.44.00 lakhs, in the past three years.
- 3. The bidder should furnish a copy of Class- II or above registration and work completion certificates and financial turnover of last 5 year along with their application for tender.
