



Sealed tenders are invited in duplicate, from class-I contractors of KPWD/CPWD or equivalent, for "**Construction of SAMat building**" of JNCASR at Jakkur Campus.

Note:

1. The Estimated Cost of the work is **560.00 lakh**.
2. The bidder should have executed similar works in large research institutions like IIT'S, IISc, NCBS, ISRO, CeNS, TIFR, JNCASR and other establishments. The contractor should have executed a single project of value not less than Rs.4.50 Crore, in the past three years.
3. The bidder should furnish a copy of Class- I registration and work completion certificates along with their application for tender. Financial turnover of last 5 years, Income tax clearance certificate, labour department registration.
4. Application form for the tender document should be addressed to the Administrative Officer JNCASR and submitted to the Project Engineer, JNCASR on or before **08.12.2021**. The short-listed contractors will be informed through an e-mail, to collect the tender forms.
5. Tender forms along with specifications, schedule of quantities and conditions will be issued during **16th and 17th December, 2021 up to 5.00 PM**, only to the short-listed contractors after verification of the credentials and proof of technical and organizational competence to carry out the work, on submission of a Demand Draft for Rs.15,000/- drawn in favour of **Administrative Officer, JNCASR, Bengaluru**.
6. Last date for submission of completed tender form along with EMD of Rs.8,40,000/- (Rupees eight lakh forty thousand only) on or before **5th January, 2022, by 2.00 PM**. The EMD in the form of a DD should be drawn in favor of **Administrative Officer, JNCASR**.
7. Tenders will be opened at **2.30 PM on 5th January 2022**.
8. The time limit for completion of the building is **Fifteen (15) Months**.

6. The firm has a registered office in Bengaluru.
7. The firm has completed all past projects as per agreements without any legal disputes and within reasonable time frames.
