The purchase shall have to satisfy himself on inspection of the vehicle as to what they contain and make his offer. Therefore, the principal of "CAVEAT ENPTIR' (Let the buyer beware" will apply.
- 2. On confirmation of the sale to the successful tenderer's should pay full payment immediately with seven days of the receipt of Sale Order (Confirmation of Sale). The last day of the tender opening is the basis for calculating the days for purposes like payment. Lifting of old vehicle, charging of interest and ground rent etc.
